**ELIGIBILITY CRITERIA:-**
**Age :-**

Should have completed minimum 18 years of age but should not be more than 26 years of age, as on 13.12.2016. Relaxation shall be granted in the upper age limit as per Government guidelines admissible to SC/ST/OBC/PWD/Ex-servicemen candidates.

**Relaxation in Upper Age Limit**

General (Unreserved)	NIL
Scheduled Castes/ Scheduled Tribes SC/ST	5 years
Other Backward Class (Non-creamy Layer)	3 years
Persons with Disability (PWD)	10 years
Widows, divorced women and women legally separated from their husbands who have not remarried	9 years
Ex-Servicemen/ Disabled Ex-servicemen	Actual period of service rendered in the defence forces + 3 years (8 years for Ex-servicemen belonging to SC/ST) subject to a maximum age limit of 50 years
Persons ordinarily domiciled in the state of Jammu & Kashmir during 1.1.1980 to 31.12.1989	5 years
Persons affected by 1984 riots	5 years
Regular employees of the Union Carbide Factory, Bhopal retrenched from service (Applicable to Madhya Pradesh state only)	5 years

The relaxation in upper age limit to SC/ST/OBC candidates is allowed on cumulative basis with only one of the remaining categories for which age relaxation is permitted.

The maximum age limit specified i.e. 26 years is applicable to General Category candidates

**Educational Qualification:**

- A pass in Xth Standard examination or its equivalent.
- The candidate should be able to read and write in local vernacular language. Knowledge of English will be given added weightage.

**Application Fees:**

Application Fees/ Intimation Charges Payable shall be as follows:

- Rs. 100/- for SC/ST/PWD/EXSM candidates
- Rs. 400/- for all others

**Methods of Payment:**

1. **Online Payment (Credit Card, Debit Card & Net banking)** - Bank Transaction charges for **Online Payment** of application fees/ intimation charges will have to be borne by the candidate.
2. **Offline Payment (Bank of Baroda Challan)** - On completion of the application on the online portal, it generates a Pay-in-slip for payment of fee (**Bank of Baroda Challan**). Only this Pay-in-slip should be used for depositing the fee, to enable the fees to be properly credited to Bank's account. **Go to the nearest Branch of Bank of Baroda** with this pay-in-slip and deposit the required amount in the Branch using this **auto generated** pay-in-slip only.
